Pro-Liquid CONCENTRATE is a highly concentrated liquid inoculant that contains live nitrogen-fixing bacteria for the inoculation of soybeans. This product contains:
(Bradyrhizobium japonicum)

Minimum Guarantee: 10 Billion (1×10^{10}) infective viable cells per gram.

Directions for use, rates and storage:

- **Directions:** Pro-Liquid CONCENTRATE is a highly concentrated liquid Inoculant. Shake product well before use. Dilute the Pro-Liquid CONCENTRATE at the ratio of one part Pro-Liquid CONCENTRATE to 5 parts of Chlorine-Free Water. After diluting, apply the diluted inoculant mixture at the rate of 3.33 fl oz per 100 lbs of soybean seed (2 ounces per bushel).
- **For optimal coverage:** For optimal coverage of the soybean seed, apply Pro-Liquid at the rate listed above to 1/2 to 1 bushel quantities. Apply the inoculant so it is thoroughly mixed with the soybean seed.
- **Storage:** Pro-Liquid CONCENTRATE contains live nitrogen-fixing bacteria. It is important to store in a cool place, between 40° - 77° F (4° -25° C) out of direct sunlight or conditions where temperatures would increase significantly. This is a dated product that must be used prior to expiration date on box label.
label. **DO NOT ALLOW PRODUCT TO FREEZE.**
- **Adverse Conditions:** For improved nodulation on soybeans in soils where soybeans have not been planted within the past 3 years or longer, soybean growers often double the application rate. The double application rate is also used if there are adverse conditions, such as sustained high temperature, lack of moisture, or extremely windy conditions.
